OVERVIEW

This guide is designed to help you understand the messages used in the integration process with the Information System (IS) provider such as Practice Management, Electronic Medical Record, or Electronic Health Record.

Konica Minolta Healthcare Americas, Inc, (KMHA) provides the following options for IS integration.

- **Modality Worklist (MWL)** This is a DICOM service that bridges the information system and the modality (X-ray) together. The purpose of this integration is to provide patient demographic information directly to the modality to eliminate the need for manual data entry. By doing this, the probability of typographic errors in the patient's demographics is reduced. Additionally, by eliminating the time required for manual data entry, the acquisition process becomes significantly more efficient. This use of this feature requires an Inbound Order (ORM) or Scheduling (SIU) message.
- Orders (ORM) This interface will be using order specific messages that contain all PID, Date and time of service, Modality type, Procedure code and Procedure Description, Referring Physician Code and Description. These orders will be new, cancelled, and updates based on the accession number of the associated order. This is accomplished via an HL7 message using an ORM^O01 message type.
- HTTP(S) URL Link The process of embedding a hyperlink into the Information System that will trigger direct access to the study images within the PACS. This logic can be hardcoded in the third-party information system or sent to the Information System via an ORU^R01 message type.
- **Reports Results (ORU)** Textual report data, created either in the PACS or a third-party entity (such as a Reading Radiologist), that is sent to the PACS via HL7 to your Information System. This is accomplished via an HL7 message using an ORU^R01 message type.

MODALITY WORKLIST

Before getting into the configuration details for MWL, let us first look at how it works and what variables there may be. MWL is a service that is part of the DICOM standard. This service is part of what is referred to as an MWL Server or MWL Broker. It provides DICOM modalities (such as digital x-ray systems) a list of patients that are to have an exam and in some cases what specific exam has been ordered. This information is provided to the MWL service from an ORM HL7 messages sent from your information system.

• Orders (ORM) – This message contains the same basic information housed in the SIU, but with the added details of what type of X-ray exam has been ordered by the physician. Order specific messages will contain all PID, Date and time of service, Modality type, Procedure code and Procedure Description, Referring Physician Code and Description. These orders will be new, cancelled, and updates based on the accession number of the associated order.

With an ORM, only the patients assigned to that station will appear.

Setup of the MWL will require the following information.

- Server IP Address:
 - > Variable and is assigned to the server at install
- Port Number for Inbound ORM messages
 - ≻ EXA 1337
- Port Number to pull the Modality Worklist (MWL)
 - ≻ EXA 4105
- Port Number to send DICOM images
 - ≻ EXA 104
- AE Title
 - ➤ EXA EXA_MWL

REQUIRED SEGMENTS AND FIELDS

The following are the <u>required</u>, fields and segments, <u>unless otherwise noted</u>. We will use the following segments and fields for the configuration. Edits or modifications must be done within the EMR/EHR.

Segments:

 - MSH Message Header
 - > PID Patient Identification Segment

Fields:

 - PID-2 Must contain the Patient Account Number/Visit Number/Encounter Number if you would like it returned in field PID-18 within the ORU message
 - > PID-3 Must contain the Medical Record # for the patient
 - PID-5 Patient Name
 - > ORC-1 Must contain the proper Order Control Code
 - > ORC-2 and ORC-3 Must contain the Accession #
 - > OBR-2 and OBR-3 Must contain the Accession #
 - > OBR-4 Must contain the Procedure code (Appointment code/Ref Code) and description
 - OBR-24 Must contain the Modality Code

Please note:

- All received messages should be wrapped as follows: CHAR (11) + Message + CHAR (28) + CHAR (13)
- \circ $\;$ Each segment of the message needs to be separated by CHAR (13).
- \circ $\;$ The same format will be used on our outbound messages.
- An ACK will be sent for all successfully processed messages.
- A NACK will be sent for all errors

Http(s) URL Link

Http(s) URL Link is a feature for the images from PACS to be viewed from your Information System (IS). Exam images are not really viewed in your IS, rather they are launched or triggered from within the application.

This is accomplished using HTML hyperlinks or URL's. The URL can be placed in the Information System:

- By the IS vendor
- By imbedding the URL logic into the application
- Or by receiving the URL via an HL7 message.

Depending on the interface type, the approval of a report, or a completed status of the study, the application will trigger a **Result (ORU)** message or **Medical Document Management (MDM)** message with the link to the EMR/EHR application.

The ORU is the preferred method of sending the URL link. The link for the image will be listed in OBX-5 of the last OBX sent. Typically, this message only has one OBX segment:

If the MDM message is used, the URL for the image will be listed in OBX-5 of the last OBX sent. Typically, this message only has one OBX segment:

Once the URL has been established, the URL can be used to invoke two types of triggers:

- Opening of Specific Study This launches the PACS viewer and displays a specific exam.
- Opening/Displaying a Study List for a patient This launches a patient specific list of all exams that a specific patient has had. From this list you can then select the exam that you wish to review. This allows you to see priors for comparison.

URL logic for embedding into a third-party application

By providing your Information System vendor with this information, they should be able to embed the logic into their application. Below you will find several variations of the URL. In each, your vendor is only required to populate one segment of the string with variable data.

Opening the URL Link for a specific Study:

To open a URL link for a specific study, one of the following is required:


- DICOM study UID [information generated by modality]
- Accession Number [Information provided to modality by MWL and/or technician]
- Patient ID [Information provided to modality by MWL and/or technician]

The third-party vendor is required to open the URL in Google Chrome, Microsoft Edge, or Safari. <u>Internet</u> **Explorer is not supported**.

URL Link Results:

When the URL link to a specific study is opened, the result will look like the example below.



Displaying the URL Link Study List:

To open a list of studies for a specific patient, the Patient ID is required. From the list the user can select a study to open by double-clicking the row on the list.

The third-party vendor is required to open the URL in Google Chrome, Microsoft Edge, or Safari. **Internet Explorer is not supported:**

REPORT RESULT

The reporting structure is usually handled by using empty OBX.5 fields to represent line breaks. As another option, we can send the report in a single OBX segment using the tilde character (field repeat separator) as the line feed.

Please note that the report can be configured such that addendums are sent containing the full report or just the addendum itself.

Outbound Result Message (ORU) Structure

Please see the list of fields we can send, and note that some fields populate only if the data is received from the originating EMR/EHR/PM system. Other fields may be available for output based on data sent to our system. If the mapping of these fields is different, please enter the correct mapping into the last column and return the document to your Integration Developer.
